The **Mainstream Voucher** Waitlist will open on Friday, February 1, 2019 at 8:00 A.M. and will remain open until further notice.

Mainstream Vouchers will assist Non-Elderly persons with a disability who are homeless or at risk of being homeless and or who are transitioning out of an institution or at risk of being institutionalized. To Qualify for a Mainstream Voucher, you must meet HUD’s definition of Homeless and Disabled. You must also be referred and have a referral form from one of the follow social service agencies:
